

SUMMARY ANNUAL REPORT FOR BROTHERS NATIONAL, LLC EMPLOYEE BENEFITS PLAN

This is a summary of the annual report of the BROTHERS NATIONAL, LLC EMPLOYEE BENEFITS PLAN, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 85-3951987, Plan Number 501), for the plan year 02/01/2022 through 01/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with CIGNA HEALTH AND LIFE INSURANCE COMPANY, METROPOLITAN LIFE INSURANCE COMPANY and EQUITABLE FINANCIAL LIFE INSURANCE COMPANY OF AMERICA to pay certain Health, Dental, Vision, Life insurance, Temporary disability, Long-term disability, AD&D, Supplemental Life claims incurred under the terms of the plan. The total premiums paid for the plan year ending 01/31/2023 were \$3,888,684.
