The plan has insurance contracts with CIGNA HEALTH AND LIFE INSURANCE COMPANY, METROPOLITAN LIFE INSURANCE COMPANY and EQUITABLE FINANCIAL LIFE INSURANCE COMPANY OF AMERICA to pay certain Health, Dental, Vision, Life insurance, Temporary disability, Long-term disability, AD&D, Supplemental Life claims incurred under the terms of the plan. The total premiums paid for the plan year ending 09/30/2023 were \$4,137,609.
