## SUMMARY ANNUAL REPORT FOR PAVEMENT PARTNERS, LLC WRAP BENEFIT PLAN

This is a summary of the annual report of the PAVEMENT PARTNERS, LLC WRAP BENEFIT PLAN, a health, life insurance, dental, vision, temporary disability and long-term disability plan (Employer Identification Number 87-1218551, Plan Number 501), for the plan year 10/01/2022 through 09/30/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Insurance Information**

The plan has insurance contracts with UNITEDHEALTHCARE INSURANCE COMPANY, STANDARD INSURANCE COMPANY, AMERITAS LIFE INSURANCE CORP. and NEW BENEFITS LTD. to pay certain Health, Indemnity Contract, Life insurance, Long-term disability, Temporary disability, Dental, Vision, Teleadvocay claims incurred under the terms of the plan. The total premiums paid for the plan year ending 09/30/2023 were \$2,796,364.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 09/30/2023, the premiums paid under such "experience-rated" contracts were \$174,295 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$61,566.
